SUBJECT: Increase to Certain Filing Fees to Take Effect December 1, 2020

DATE: November 6, 2020

At its March 2020 session, the Judicial Conference approved inflationary adjustments to certain fees on the Bankruptcy Court Miscellaneous Fee Schedule which go into effect on December 1, 2020.

The fee for filing certain motions, including motions for relief from the automatic stay, will increase from \$181 to \$188. The administrative fee for each new bankruptcy case filing will increase from \$75 to \$78 for Chapter 7, 12 and 13 cases and from \$550 to \$571 for Chapter 9, 11 and 15 cases. In addition, the fee for a motion to redact and a transfer of claim will increase from \$25 to \$26.

A complete list of the filing fees that will increase **effective December 1, 2020**, is attached. Filing fees not listed on the attachment remain the same.
